



2011 Santa Barbara County Fair Adam's Camping Information & Application

We look forward to your participation in the 2011 Santa Barbara County Fair. The fair dates are July 13th – July 17th, 2011, during which we will be celebrating our theme of “Bright Lights and Magical Nights”. To accommodate your camping needs we ask that you read the following rules and regulations. Please complete the application enclosed. Our camping spaces are 20' X 30'. **If your camper/RV is larger than the space available you must purchase 2 camping spaces for that camper/RV.** Tents may only be used as extra sleeping space in conjunction with self-contained camping units.

All applications must be in a sealed envelope clearly marked “Adam's Camping Application”.

Envelopes will be drawn randomly to determine the order of application registration and space assignments.

You need not be present for the drawing. If your choices are not available, spaces will be assigned based on availability. If you wish to camp with a certain individual and/or group then applications must be submitted in the same envelope. If all applicants use separate envelopes we cannot guarantee you'll be next to any other campers based on where you are drawn in the lottery. You are responsible for your group and/or your application. We will not add any applications to any groups or individuals that have already submitted their applications.

A waiting list will be created if there are more applications than spaces and you may be contacted up until the day the Fair starts if we have a space become available.

Camping applications may be mailed or dropped off, but must be in hand at the Santa Maria Fairpark no later than 4:00 PM on Friday, May 6, 2011. Postmarks will not be accepted.



2011 Camping Fees

- Camping Fee (per space)**..... \$155.00
(Camping fee includes: 1 camping spot, 1 parking space, and a mandatory city administration fee of \$15.00)
- Stock Truck Pass for Strawberry Lot ONLY..... \$25.00
- *Stock Trucks are NOT allowed in the Adam's Camping!

****One Parking Pass per Camping Spot. No additional parking will be sold for Adam's Lot Parking. Strawberry Lot season parking pass can be purchased during pre-sale at the Administration Ticket Window.****

Trailers (e.g. stock, utility, horse) will be admitted in the Strawberry Lot Parking across the street with a proper stock truck parking permit including license plate number. These can be purchased for an additional \$25.00. **THERE WILL BE NO EXCEPTIONS.** If a car is parked in Adam's Lot without the proper pass, the vehicle is subject to towing at the owner's expense.

Applications that are incomplete will not be accepted.

A service charge of \$25.00 will be charged for any returned checks.

Please read Adam's Camping Policy.

Individuals wishing to camp next to each other are advised to submit their applications together. Note: If spots are not available together the group will be broken up according to availability. Applicants must designate first, second, and third choices. We cannot guarantee you will receive the spaces you requested.

Note: Adam's Camp Ad-Hoc Committee designated by Fair management will coordinate assigned camping spaces on arrival Sunday, July 10, 2011.



2011 Adam's Camping Policies

1. **ALCOHOL IS PROHIBITED IN ADAM'S CAMPING.** Any youth exhibitor in violation of this rule will be removed from showing and selling their animal at the 2011 Santa Barbara County Fair. If the exhibitor's animal has already been sold, the money will be returned to the buyer and that animal will not be sold through the JLSA. The exhibitor's privileges will be revoked from camping at Adam's Campground. He/she must submit in writing to the Santa Barbara County Fair Board to be reinstated to be eligible to show and camp at the 2012 Santa Barbara County Fair. Any Adult in violation of above rule will be removed from Adam's Camping.
2. **AN ADULT CHAPERONE (25 YEARS OR OLDER) MUST BE AN OCCUPANT OF THE CAMPER/RV!** No permits will be issued to minors staying alone. A maximum of 6 exhibitors per Adult/Chaperone. Chaperones will be responsible for enforcing a 10:00 PM curfew in the camping area (**all exhibitors must be in their assigned camp area and noise is to be kept to a minimum.**) If exhibitors are camping without chaperones they will be asked to leave and parents will be notified. The camper/RV will be removed from the Adam's campground. The exhibitor's participation in the 2011 Santa Barbara County Fair can be revoked.
3. Whomever's name is on the camping application will be responsible for their assigned space, their guests, and any activities of their guests
4. **Camping spaces are 20'x 30'.** If your camper/RV is larger than 20'x 30' you must purchase 2 spaces.
5. No pets, livestock or horses are allowed in Adam's camping.
6. No fireworks are allowed in Adam's camping or the Fairgrounds.
7. Tents may only be used as extra sleeping space in conjunction with a self-contained campers/RV's.
8. **NO DUMPING OF SEWER ON THE GROUND ALLOWED!** All campers/RV's must be self-contained for both sewage and wastewater. Camping spaces will be checked for damages such as: broken sprinkler heads, garbage, sewage, holes dug in the ground, etc. We would like to remind you that this is a city park and damages will be assessed and billed accordingly.
9. Fire pits must be self-contained. Ash receptacles must be used, this will be checked and any site with burned grass or dumped ashes will be billed accordingly.
10. Vehicles must be parked in the designated parking area on the north side of Adam's camping and must have a proper parking sticker displayed correctly on upper left corner of front window. Vehicles will not be permitted without parking sticker. **Any vehicle in Adam's camping or parking without a proper Parking Sticker will be towed at the owner's expense.**
11. Vehicles are not allowed in the campground after Monday, July 11th, except for restocking, 7:00 am to 8:45 am through July 16th. Vehicles not removed by 9:00 am will be towed at owner's expense.
12. Campers will not be permitted into Adam's Camping without proper camping sticker. Camping sticker must be visible on window of camper/RV unit.
13. **ARRIVAL TIMES**
Sunday, July 10, 2011 between the hours of 7:00 a.m. and 8:00 p.m. Campers will not be admitted prior to 7:00 a.m. on Sunday. **THERE WILL BE NO EXCEPTIONS.**
Monday, July 11, 2011 between the hours of 8:00 a.m. and 5:00 p.m.
14. **DEPARTURE TIMES**
Campers may begin leaving Adam's camping at 8:00 am on Sunday, July 17th and must be completely removed by noon on Monday, July 18th.
